## **System Overview**

The Signetor system consists of two main components: the management portal and the scanners. In the management portal, your organization is set up with users and scanners. Clients are organized under your organization, offering a straightforward structure. For each client, you can set up a location hierarchy, product catalogues, stock levels, and create jobs. The necessary scanners and users can be assigned to all jobs below your organisation.

Once configured, the assigned scanners download jobs via an internet connection. After download, no further internet access is needed, as all data is stored on the scanners. Scanning activity can be uploaded during breaks or at the end of the day. All scanner data is automatically consolidated in the Management Portal, with a comprehensive audit trail for all stocktakes.



## Catalogues

Stocktake catalogue information can be built exclusively with customer data, using Signetor master data or a combination of customer and Signetor product data. The objective is to ensure the highest product recognition during scanning allowing fast & accurate stocktakes

- ➤ Customer Supplied Customer catalogues can be loaded into the management portal. Barcodes can be GS1 or internal. Products can have more than one barcode per product when configured as aliases.
- ▶ Hospital Clinical Many hospitals do not have an inventory system and / or have an incomplete list of product barcode information. To enable hospital stocktakes Signetor maintain a clinical product dataset with over 5 million barcodes that can be utilised to ensure fast & accurate stocktakes for hospital clients.
- ▶ Pharmacy Catalogue Maintaining both Chemist + Druggist (C+D) and Irish Pharmacy Union data. It is possible to add additional wholesale catalogues and EPOS information to create a bespoke catalogue for your pharmacy customer.

# **Label Printing**

Print Staff ID, product shelf labels and location labels directly from the Management Portal. Allowing you to streamline your customers inventory controls, increasing accuracy and reducing the time required to stocktake.


